Within this material we have included a list of our services specific to your wedding day and preparation for that special day. We offer services for you, your Bridal Party and the Groom.

Our Bridal Contract, including our Terms and Conditions, has been included in this packet. Once the contract has been signed, Terms and Conditions have been initialed and your Down Payment has been received, you will be guaranteed your reservation for you and your Bridal Party. We offer a complimentary consultation with our Guest Relations Director to answer any questions or concerns you may have.

Terms & Conditions

Please initial each statement that follows. You will be responsible for letting your entire Bridal Party know the Terms & Conditions and you agree to be financially responsible for their reservations if they fail to show or pay.

___ To accommodate service requests and reservations times for your party, it is imperative that arrangements are confirmed with our Guest Relations Director at least 30 days prior to the event. We understand that unforeseen events can happen in the planning of any occasion and we will make every effort to meet your needs. However, our Salon & Spa reservations are often reserved far in advance and changes within 30 days may not be possible, depending on availability. We greatly appreciate your efforts to finalize all service needs early in your planning process.

___ Brides are **required** to have a Trial Updo performed before the event date. IF the bride chooses **not** to have the trial performed, the \$35 trial charge will be added to the bridal charge on the day of the wedding. Trials are very important to ensure that you get the style that you desire and gives that stylist the advantage of preparation.

___ Food and drinks are welcome on the day of the event. IF you choose to bring your own food and drink, it is expected that you would arrive 15-20 early to set up. We need to start your services on time to ensure that you are running on schedule. If you would like us to cater for you on the wedding day, it may be arranged with our Guest Relations Director.

___ You and your Bridal Party are expected to arrive 15 minutes prior to your scheduled reservation. For every 5 minutes that you or any of your Bridal Party arrive *past your scheduled reservation time*, a \$5 charge will be added to that persons bill.

____ On the Wedding Day, **each and every person** that is getting a Hairstyle **must arrive with completely dry hair**. If we must dry it to begin your service, there will be a \$30 blow dry fee added.

____ Hair accessories can be used to accentuate your style. Veils, tiaras, clips, combs, flowers and other types of hair accessories can be incorporated into your style for added elegance. John Taylor Day Spa is not responsible for accessories that are broken or damaged.

____ The Bridal Party guests must cancel their reservation 1 week or more **prior** to the Wedding Day for a full refund. No refund will be given for anyone in the party who misses their reservation.
